Tournament Rules, Regulations and General Tournament Information

Please Read Carefully

1. **This Gr. Cincinnati USBC WBA fund raising tournament** is an individual, Mail-O-Graphic Tournament. It is open to all USBC members and will be conducted by submitting USBC certified league scores bowled during the month of February. Bowlers may enter, and cash, once per league using the best (3) game series from that league for the month of February.
2. **Handicap** - The tournament will be 90% handicap based on a 220 average for both women and men. Handicap will be based on the highest certified league average for the 2007-2008 season. If a bowler does not have a certified average for 2007-2008, the current average may be used from a certified league with a minimum of 12 games as of January 31, 2009. All others are welcome to enter but will bowl scratch (220 average).
3. **Entry Fee** is \$20 per league. Complete fees must accompany the entry form and will cover a \$15 donation to the Bowlers to Veterans Link, and the remaining \$5 for the prize fund. There are no expenses since all time, materials and copies are donated.
NOTE: Any check returned from the bank will be subject to \$30 service charge.
4. **Prizes** - The prize fund will be returned 100% and will be based on a minimum of one (1) cash award for every five (5) entries. Women and men will have separate prize funds based on number of entries in each category.
5. **Disqualification** - An entrant, while participating in a scheduled event, may be disqualified for any of the following reasons: An infraction of the rules; use of foreign substance which comes into contact with the approaches or lanes; conduct derogatory to the best interest of the tournament and/or use of an illegal bowling ball. Disqualification of an individual shall result in forfeiture of the entry fee and any right to prize money and/or awards.
6. **Publicity** - All participants agree to allow Gr. Cincinnati USBC WBA or USBC to use their name and/or photograph for any publicity purpose.
7. **Disputes** - The Tournament Committee shall have the power to hear and act on disputes, complaints or protests relating to the Tournament. The decision of the Committee is final except when an appeal is made to USBC.
8. **Falsification** - Any contestant who knowingly falsifies any information will result in forfeiture of the entry fee and any right to prize money and/or awards.

The Entrant whose name appears hereon or their replacement agree that the Gr. Cincinnati USBC WBA, its officers and agents shall be liable only to the extent of returning entry fees if and when the entrant shall be prevented from bowling in the Tournament through premature termination of the Tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto, or resulting there from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Gr. Cincinnati USBC WBA.
